#### **CALL TO ORDER:**

Vice-Chairman Robert Moss welcomed the media, Council Members, and the staff, and called the meeting to order at 4:00 P.M.

Richard Laundenslager stated he was told fluoride was added to the water, but the report says it comes from the erosion of natural deposits. Commissioner Aaron Haines stated he would be happy to meet with Richard Laundenslager in his office, and give him a tour of the plant. Richard Laundenslager thanked Commissioner Aaron Haines.

## **BOARD/STAFF REPORTS & INFORMATION:**

# A. Commissioner's Report

- 1. Main Street Water Line Project Commissioner Aaron Haines stated in regards to the Main Street Water Line Project, Terra Works is moving along rapidly and efficiently with very few snags. Commissioner Aaron Haines stated there is about thirteen hundred feet of the project remaining. Commissioner Aaron Haines stated they met with representatives from LB Water and American Pipe Manufacturing of Alabama, and learned there has been a recent price increase to the tune of twenty-two dollars per foot of pipe. Commissioner Aaron Haines stated when he asked when Terra Works will get the remainder of their pipe, they could not give us a date. Commissioner Aaron Haines stated they said the pipe is being produced every day, but they simply cannot meet the current demand across the country. Commissioner Aaron Haines stated due to the material shortage, they had a meeting with PENNVEST today to see if an extension could be granted without jeopardizing the funding, and they said that would not be a problem, as many of their partners are experiencing the same shortages.
- 2. Phase Two of the Filter Module Replacement Commissioner Aaron Haines stated for phase two of the filter module replacement, where we just got the sixty installed, they are recommending that we go ahead with an order for next year if we even want to see them for next year. Commissioner Aaron Haines stated since the money is already earmarked for that, he will go ahead and place an order.

## **B. Solicitor Jim Dennison**

1. <u>Main Street Water Line Project - Right of Way Agreements</u> – Solicitor Jim Dennison stated most of the people are pretty cooperative on these connection agreements. Solicitor Jim Dennison stated they are coming along.
