CALL TO ORDER:

Chairman Kutz called the meeting to order at 6:00 P.M.

CORRECTIONS/APPROVAL OF MINUTES:

Member Smith moved to approve the minutes of the February 27th and March 11th Planning Commission meetings; seconded by Member Park. Motion carried 4-0.

CHAIR REPORT:

PUBLIC COMMENT:

None

DEVELOPMENT PLANS:

- **A.** <u>Brookville Equipment Company rezoning request</u> Chairman Kutz stated this issue is being tabled for a future meeting.
- **B.** Courthouse Alley Pedestrian Walkway Chairman Kutz reported that since this issue was handled by Brookville Borough Council, it was removed from the Commission's deliberations.

COMMUNITY PLANNING:

A. <u>Bureau of Recreation and Conservation Call for Grant Proposals</u> – Manager Gable stated that this item has been tabled since HBI in consultation with Borough Council deemed it more advantageous to apply for the grant to be dedicated to the Town Square Project. Competing grant proposals from the same community are not favorable for awarding the grant.

- **B.** <u>Capital Improvement Program (CIP)</u> Chairman Kutz and Manager Gable agreed that this item should be tabled until Member Richards is present.
- C. <u>2013 Work Plan</u> Manager Gable wants the Planning Commission to think about what projects they want to work on.

NEIGHBORHOOD PLANNING:

- **A.** <u>Crestwood Mobile Home Park</u> Borough Engineer Dan Slagle looked over Site Surveyor Ken Berlin's plans for Crestwood Mobile Home Park. Engineer Slagle stated that the Planning Commission needs to discuss these issues:
 - 1. Is this a PRD (Planned Residential Development) subdivision? Engineer Slagle stated that a PRD would require a public hearing. The Zoning Hearing Board Council would decide if this is a PRD.
 - **2.** Is exiting the trailers onto Brush Street satisfactory?
 - **3.** The Planning Commission should discuss the screening that would be in the back
 - **4.** Engineer Slagle stated the Planning Commission needs to develop a lighting plan.

Engineer Slagle stated that Site Surveyor Ken Berlin needs to address several issues. Engineer Slagle recommended that Site Surveyor Berlin ask for an extension. Engineer Slagle also stated he does not recommend doing a traffic study. Member Smith moved to table the Crestwood Mobile Home Park plan on the condition that the developer file a 60 day extension; seconded by Member Park. Motion carried 4-0.

PUBLIC COMMENT:

<u>Dickson Tattersall</u> – Citizen Dickson Tattersall was present. Citizen Tattersall stated that he lived at 10 Brush Street. He stated there is a lot of traffic there and it is fast in that area. He presented the Commission a signed petition against the expansion of Crestwood Mobile Home Park.

B. Geist Way Subdivision Proposal – Member Park moved to grant final approval to Phil Hetrick's subdivision; seconded by Member Smith. Motion carried 4-0.

ADJOURNMENT:

With no further business to be discussed, Member Park made a motion to adjourn at 7:10 p.m.; seconded by Member Smith. Motion carried unanimously 4-0.
